



Application Form Hermit's Peak Wildfire Relief Fund

Overview

The Las Vegas New Mexico Community Foundation (LVNMCF) is now accepting applications from nonprofit organizations for grants from the Foundation's Hermit's Peak Wildlife Relief Fund.

We established the fund on April 24, 2022, to address critical gaps in charitable nonprofit services to the Mora and San Miguel communities during and after the Hermit's Peak/Calf Canyon wildfires.

1.0 To be eligible organizations:

- 1.1 **Must hold 501c3 nonprofit status** from the IRS or have a fiscal sponsor.
- 1.2 Must provide emergency-relief services directly provided/ related to Hermit's Peak, Calf Canyon or Cooks Peak Wildfires, in Mora and San Miguel Counties, NM.
- 1.3 Shall only submit one application per announced grant round. Multiple grant cycles may be announced based upon available funds.

2.0 Applications

- 2.1 Grants of up to a maximum amount of \$10,000 (per cycle) will be awarded.
- 2.2 This application will be considered separate from any other grant application submitted to the LVNMCF in 2022. No information provided in this request will influence any additional funding decisions that we may consider from your organization this year.
- 2.3 Applications may be submitted and reviewed on a rolling basis. LVCF will do its best to respond within 5 days of all submission contingent upon grant funding being available. Requests not immediately funded will continue to be considered depending on available funds basis.
